Meaningful Use – 2015 thru 2017

- In 2015 90 days or LONGER
- 2016 or 2017 1st reporting year 90 days, all others full calendar year
- Newly credentialed doctors 2 year reprieve from penalties
- 2018 All participants will be Stage 3
- 10 objectives all must be met or excluded
- Attestation for 2015 begins 1-4-16
- Must attest by 2-29-16 for 2015
- The deadline for Eligible Professionals to submit hardship applications for the 2017 payment adjustment, based on the 2015 EHR reporting period, will be July 1st, 2016.
- Discontinued Criteria: Demographics, Vitals, Smoking Status, Lab Tests, Clinical Summaries,
 Patient List by Diagnosis, Preventive Care Reminders, Imaging Results, Family History,
 Progress Reports, Submission to Cancer Registry

Objective 1: Protect Patient Health Information (Security Risk Analysis)

- Can use tool from ONC
- WWW.HEALTHIT.GOV
- Must be performed in the 1st year (does not have to be during reporting period)
- Must be reviewed each subsequent year

How is this calculated in Compulink?

• This is a self-report measure – nothing to track in Compulink.

Objective 2: Clinical Decision Support (HCM Rules)

- Stage 1 Implement 1 rule
- Stage 2
 - o Measure 1: Implement 5 rules, 4 of which are CQM's
 - Measure 2: Yes/No Enabling and implemented drug-drug and drug-allergy interaction check

- Stage 1 This is a self-report measure. You will attest Yes or No. Attesting yes indicates that you have turned on at least one HCM Rule within Compulink.
 - HCM Rules are found under Utilities/Health Care Maintenance Rules/Orders / Rules



- Compulink has a number of pre-set orders you may turn on or off. You may also opt to customize your own rules.
- Stage 2
 - Measure 1 This is a self-report measure. You will attest Yes or No. Attesting yes indicates that you have turned on at least five HCM Rules within Compulink
 - Measure 2- This is a self-report measure. If you are prescribing medications and using New Crop for e-prescribing, you will attest "Yes" to indicate that you are using a solution that performs drug-drug and drug-allergy interaction checks.

Objective 3: Computerized Physician Order Entry

- Stage 1 >Measure 1 30% of medication orders
- Stage 2
 - Measure 1 ->60% of medication orders
 - Exclusion: <100 orders during reporting period
 - Measure 2 >30% of laboratory orders
 - Exclusion: <100 orders during reporting period
 - Measure 3 >30% of radiology orders (OCT, ASCAN, BSCAN, etc)
 - Exclusion: <100 orders during reporting period
 - Orders can only be entered by "licensed healthcare professionals or credentialed medical assistants"
 - CPO, CPOA, COA, COT, COMT
 - JCAHPO's new OSC
 - www.theacmss.org for scribe certification

- Stage 1- Measure 1 Only may exclude Measures 2 and 3
 - Denominator:
 - Signed Off, Exam Record dated within the reporting period,
 - At least one medication entered into EHR, by a provider in the practice, with a start date within the reporting period.
 - Numerator: Delivery method for at least one medication must be one of the following:
 - E-Rx Pharmacy
 - E-Rx Fax Pharmacy
 - E-Rx Mail Order
 - E-Rx Print
- Stage 2
 - Measure 1 Same as above Measure 1 for Stage1 except must achieve 60%



- Measure 2 –may exclude if you write fewer than 100 lab orders
 - Denominator:
 - Lab test record entered. The record must have an 'Ordered' date within the reporting period.
 - This record must have the Eligible Professional's ID in the 'Ordered By' field.
 - The record must be assigned a Type of 'Laboratory' in the Test Names table.
 - Any laboratory results on paper must be added to the denominator and you will need to manually re-calculate the percentage to accurately report.
 - Numerator:
 - Number of patients within the denominator group with a type of Labratory
- o Measure 3
 - Denominator:
 - Signed Off, Exam Record dated within the reporting period,
 - Test record added within the reporting period date range where:
 - o Ordered by is the EP
 - Radiology/Imaging is the Type (*Note this field does not display in EHR – you must insure it is entered accurately in the Test Name table.)
 - Numerator:
 - Number of patients within the denominator group with a type of Radiology/Imaging

Objective 4: E-Rx

- Stage 1 -- >40% transmitted electronically
- Stage 2 -- >50% queried for drug formulary and transmitted electronically
- Exclusion: <100 medication orders during reporting period
- Exclusion: no pharmacies nearby to accept electronic prescriptions at the start of reporting period

- Stage 1 and Stage 2
 - o Denominator records that meet the following criteria:
 - Signed off, Exam record, dated within the reporting period.



- At least one medication entered into EHR, by a provider in the practice, with a start date within the reporting period.
- Method of delivery for the medication may be anything other than "Not Transmitted" or "Administered On-Site"
- Numerator: The number of records with a Delivery method listed as one of the following:
 - E-Rx Pharmacy
 - E-Rx Fax Pharmacy
 - E-Rx Mail Order
 - E-Rx Print

<u>Objective 5: Health Information Exchange (Summary of care for Transition of Care)</u>

- Stage 1 Can exclude
- Stage 2
 - Uses Certified EHR to create summary of care and electronically transmit to receiving provider > 10%
 - o Exclusion: <100 TOC's during the reporting period

How is this calculated in Compulink?

- Stage 1- ALL may exclude
- Stage 2
 - Denominator records that meet the following criteria:
 - Signed off, Exam record, dated within the reporting period.
 - Exam records' date must fall within the Referral record's start and end date.
 - A referral, which falls within the reporting period, marked as "Out"
 - Numerator the number of records within the denominator group which have one of the following recorded in the PHI Audit Event Log
 - Direct Transfer this is a Direct Email sent to the referring provider
 - Referral Portal CCD this means the CCD has been uploaded to MySecureHealthData for the referring provider.

Objective 6: Patient Education

- Stage 1 Can exclude
- Stage 2 -- >10% of patients provided with patient specific education resources identified by EHR

How is this calculated in Compulink?

Stage 1- May exclude



- Stage 2
 - O Denominator:
 - Signed Off, Exam Record dated within the reporting period
 - O Numerator:
 - The number of patients within the denominator group that have an exam education record added within the reporting period, with a delivery method other than Verbal.

Objective 7: Medication Reconciliation

- Stage 1 Can exclude
- Stage 2
 - o Performs on >50% of transitions of care from which patient is transferred into EP's care
 - Exclusion: Did not receive any TOC's

How is this calculated in Compulink?

- Stage 1- May exclude
- Stage 2
 - Denominator:
 - Signed Off, Exam Record dated within the reporting period
 - A referral date that falls within the beginning and ending time frame of the reporting period that is marked as a type "T" referral (for "Transition of Care") and not marked as "out" (Patient -> Referral History/Eligibility screen).
 - O Numerator:
 - The number of patients within the denominator group that have an exam auditing record that shows record of a medication reconciliation during the reporting period (performed via the "Reconcile" tool on EHR medication tabs).

Objective 8: Patient Electronic Access (VDT)

- Stage 1
 - Measure 1: Making information available to the patient electronically within 4 days
 >50%
 - Measure 2: May Exclude
- Stage 2
 - Measure 1: Making information available to the patient electronically within 4 days >50%
 - Measure 2:

- 2015/2016
 - At least 1 patient views, downloads, transmits to a third party their health information
- **2017**
 - 5% of patients view, download, transmit to a third party
- Exclusions: Do not order or create any of the information listed for inclusion except for patient name, providers name, office contact info
- Exclusion: >50% of patient encounters are in a county that >50% do not have
 3Mbps broadband available

- Stage 1
 - Measure 1: Denominator:
 - Provider Signed Off, Exam Record dated within the reporting period
 - o Measure 1: Numerator:
 - the number of patients within the denominator group who have:
 - An e-mail address on their patient demographics screen.
 - The Opt Out Portal field on the demographics screen is not checked. If checked, the patient will also be included in this number.
 - A CCD document sent to the Patient Portal within 4 business days of the exam. (This can be performed either on demand by using the Portal -> Send CCD to Patient in the EHR screen, or via the Function -> Portal CCD Communication which automatically sends signed off exams).
 - Measure 2: May Exclude
- Stage 2
 - Measure 1 & 2: Denominator:
 - Provider Signed Off, Exam Record dated within the reporting period
 - Measure 1: Numerator:
 - the number of patients within the denominator group who have:
 - An e-mail address on their patient demographics screen.
 - The Opt Out Portal field on the demographics screen is not checked. If checked, the patient will also be included in this number.
 - A CCD document sent to the Patient Portal within 4 business days of the exam. (This can be performed either on demand by using the Portal -> Send CCD to Patient in the EHR screen, or via



the Function -> Portal CCD Communication which automatically sends signed off exams).

- Measure 2: Numerator:
 - The number of patients within the denominator group who have accessed their Patient Portal account within the reporting period.
 - This information is not viewable within the patient's EHR, but is stored as an Audit Event under portal activity.
 - Portal activity is automatically retrieved by the software when you run the portal function.
 - Report Percent: If this is greater than one patient, you have achieved the Measure for this reporting period.

Objective 9: Secure Messaging

- Stage 1 Can Exclude
- Stage 2
 - 2015: Y/N have the capability to send/receive secure electronic messages enabled
 - 2016: 1 patient must send/respond during the reporting period
 - o 2017: 5% of patients must send/respond during the reporting period
 - Stage 3: >25% of patients must send/respond during reporting period

How is this calculated in Compulink?

- Stage 1- May exclude
- Stage 2
 - 2015 –Self-Report Secure messaging is enabled within Compulink Version 11 or greater – as long as you are using Version 11 or greater you may attest "Yes" to this measure.
 - o 2016/2017:
 - Denominator: Provider Signed Off, Exam Record dated within the reporting period
 - Numerator: the number of Patients (2016) or percentage of Patients (2017) within the Denominator group with a PHI Audit Event of 'Portal Secure Communication' recorded during the reporting period.

Objective 10: Public Health Reporting

- Register intent for a public health measure within 60 days of reporting period
- Public Health Measures
 - Ongoing Submission to Immunization Registries
 - Exclusion:



- EP does not administer immunizations
- EP operates in jurisdiction for which no registry is capable of standards required
- EP operates in jurisdiction for which no registry has declared readiness
- o Ongoing Submission to Syndromic Surveillance Data
 - If you plan to submit Syndromic data you will need to contact Compulink to set this up.
 - Exclusion:
 - EP does not diagnose or treat any disease or condition associated with or collect relevant data required by specialized registry in their jurisdiction during reporting period
 - EP operates in jurisdiction for which no registry is capable of standards required
 - EP operates in jurisdiction for which no registry has declared readiness
 - In order to exclude, EP should contact State Public Health Department to find out if Ophthalmology/Optometry is a required reporter. This varies from state to state.
- Ongoing Submission to a Specialized Registry (IRIS and MORE in 2016+ qualify)
 - Exclusion:
 - EP does not diagnose or treat any disease or condition associated with or collect relevant data required by specialized registry in their jurisdiction during reporting period
 - EP operates in jurisdiction for which no registry is capable of standards required
 - EP operates in jurisdiction for which no registry has declared readiness
- Stage 1 1 Measure
- Stage 2 2 Measures

How is this calculated in Compulink?

• For all measures you will need to communicate with Compulink to inform them of which registry you will be using. Further reporting will come from the registry itself.
